I, the undersigned, a citizen of the United States of the age of 21 years or more, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Utah, do hereby certify:

First: The name of the Corporation shall be

Fourth: The Corporation may engage in any lawful act or activity for which corporations may be organized under the Utah Revised Business Corporation Act subject to the following purposes, and is organized exclusively for charitable and educational purposes, including, for such purposes,

- (1) the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code
- (2) the participation in and encouragement of other legal entities to collect, preserve, and distribute surname history and artifacts.

Fifth: The Corporation will file with the IRS as a 501(c)(3) organization. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Forth hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Sixth: The Corporation will not issue shares evidencing membership or interests in water or other property rights.

Seventh: The names and addresses of the persons who are the initial trustees of the Corporation and will serve as the Acting Board of Directors until such Board is formally organized as the governing voting body are as follows:

**Eighth:** Provisions for regulation of the internal affairs of the Corporation are as provided in by-laws adopted by the Board of Directors.

**Ninth:** Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
